## Penalty for Working without a Permit:

Penalty for beginning work without a permit: All fees set shall double if builder has to be notified to buy a Building Permit after work has been started.

## Cost of Advertising and Notice:

The applicant shall pay the cost of any required legal notice, and be responsible for placing the notice and providing proof of publication to the Planning Commission ten (10) days prior to any public hearing. The applicant shall be responsible for the posting of any signs as required by the Zoning Ordinance, including cost and/or construction. Sign Permit fees will not be applied to Public Hearing signs.

#### Notice:

- 1. With the purchase of a permit, the applicant is responsible for complying with all local, state, and federal regulations.
- 2. Use of a credit/debit card is permissible with the acceptance of a fee to be administered by the credit card company.
